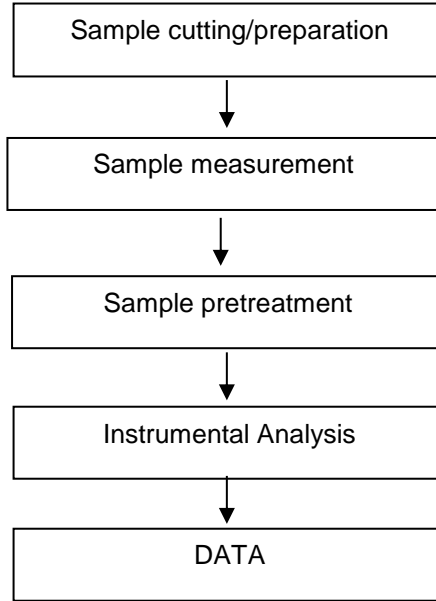

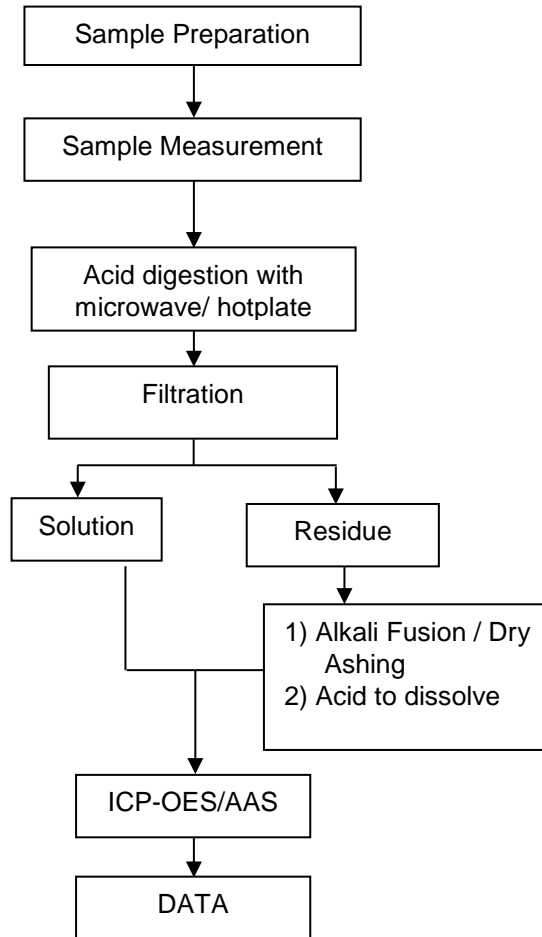

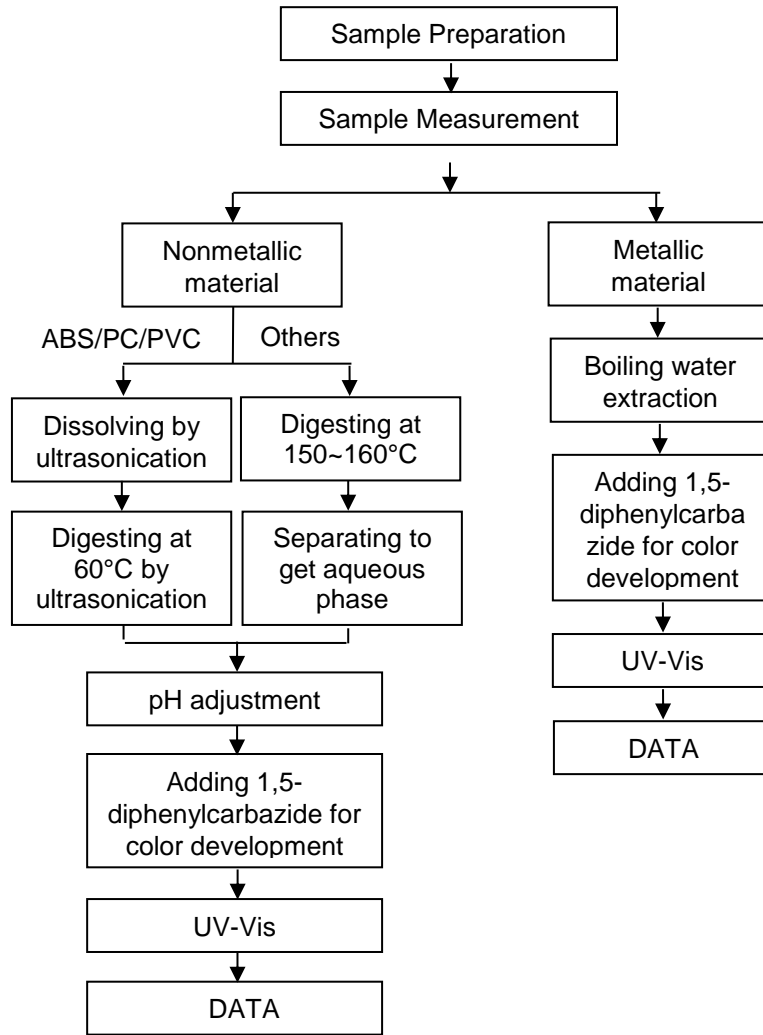

### Elements Testing Flow Chart

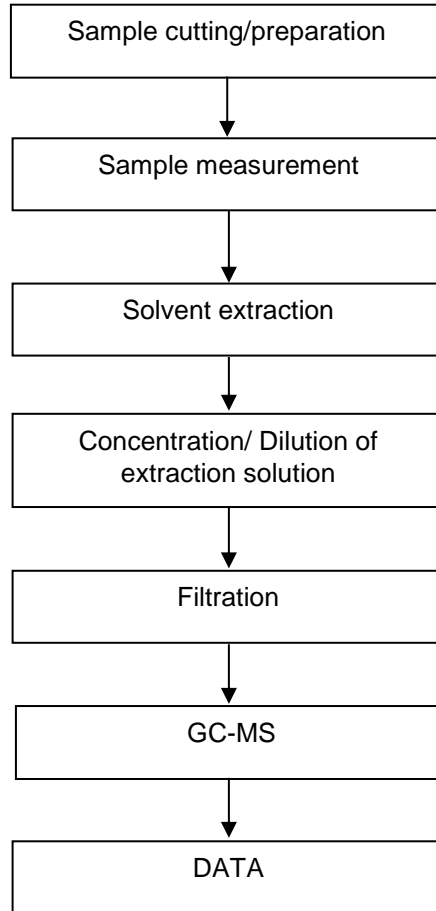

**Hexavalent Chromium (Cr(VI)) Testing Flow Chart**



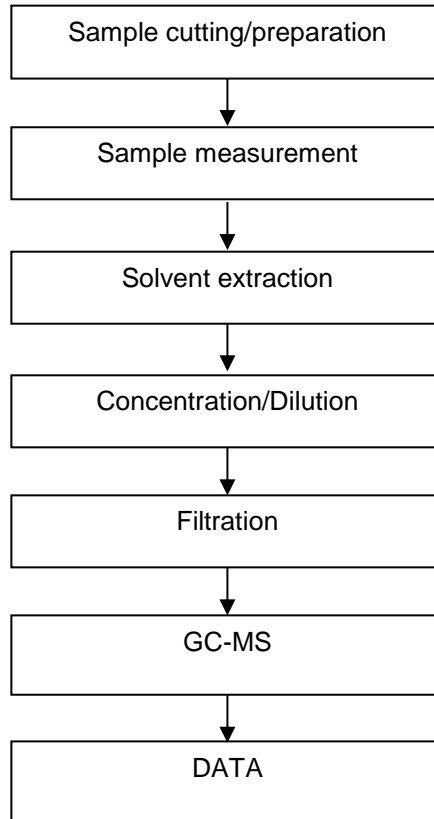

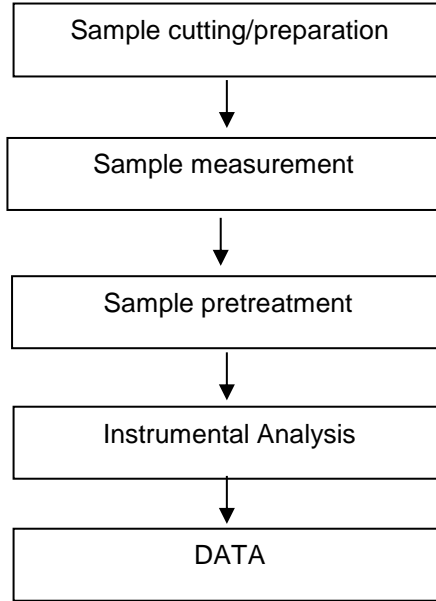
